FOCUS STATEMENT

Helping to grow a thriving economy in North Minneapolis by supporting entrepreneurs, small businesses and expanding local ownership opportunities.

PURPOSE

The Northside Commercial Real Estate Advisory Committee of The Jay and Rose Phillips Family Foundation of Minnesota is allocating \$100,000 in grants to support Black real estate developers in North Minneapolis. Applications are now being accepted for grants to cover pre-development costs for Black real estate developers with commercial or residential real estate projects in North Minneapolis. The purpose of the grants is to alleviate smaller financial burdens that often hinder the success and sustainability of developers from a historically marginalized community with limited representation in the real estate development field. Thanks to funding provided by The Jay and Rose Phillips Family Foundation of Minnesota, \$100,000 will be distributed to projects in the following neighborhoods of North Minneapolis: Cleveland, Harrison, Hawthorne, Jordan, McKinley, Near North, Sumner-Glenwood, Victory, Willard-Hay, and Webber-Camden.

GUIDELINES

What Will We Fund?

Grants are available for predevelopment costs for commercial and residential real estate projects. Additionally, these funds can be used as matching funds for other funding opportunities.

Eligible Expenses: Repairs, Inspection Fees, Architecture, Accounting / Legal Fees, Engineering, Project Management, Permits/Other Regulatory Fees, Remediation Costs, Material Costs.

Ineligible Expenses: Land acquisition, Salaries, Business operations and operating expenses.

Who Is Eligible to Apply?

Grant funds have been established to support Black real estate developers with property ownership and site control of commercial and residential real estate projects located in North Minneapolis. Projects must be located in the following neighborhoods of North Minneapolis:

- Cleveland
- Harrison
- Hawthorne
- Jordan
- McKinley
- Near North
- Sumner-Glenwood
- Victory
- Willard-Hay
- Webber-Camden

Eligible Applicants: Commercial and residential property owners with site control, Developers (for-profit).

Ineligible Applicants: Local governments

Priority will be given to applicants with development experience and education, and that have secured one or more of the following steps in their project: Subsidies, Tax Credits, Construction Financing, Zoning in Place, Entitlement Status.

APPLICATION PROCESS

The 2022 application will be released on November 10, 2022. All interested applicants are encouraged to view the grant informational webinar. This is an opportunity to learn more about the grant process and additional details. A copy of the session will be made public on November 21, 2022.

Applications must be submitted by 4 pm CDT on December 12th via the Minneapolis Foundation's online portal. Applicants are encouraged to use the worksheet below to preview and draft application questions.

The Phillips Foundation plans to award up to \$15,000 per application based on eligibility and project readiness.
